This document constitutes the Final Terms of the Securities described herein and must be read in conjunction with such Base Prospectus.

As provided in the Conditions, the Securities are governed by French Law and the Paris Court of Appeal shall have exclusive jurisdiction to settle all disputes that may, directly or indirectly, arise out of or in connection with the Securities.
