The Currency Knock-Out Warrant Call or Put Certificate is an Open End Turbo ("OET") Certificate being a leveraged security with no fixed term, which gives investors a level of exposure from moderate to high to the price and performance of the relevant Currency as described in Part A "Specific Provisions for each Series" (the "Underlying Currency") that is greater than the capital invested. The leveraged nature of the Certificates means that any movement in the value of the Underlying Currency will have a magnified effect on the value of the Certificates, both positively and negatively.

In respect of Call Certificates, the Certificates will increase in value when the Underlying Currency increases in value and decrease in value when the Underlying Currency decreases in value.

In respect of Put Certificates, the Certificates will increase in value when the Underlying Currency decreases in value and decrease in value when the Underlying Currency increases in value.

The Certificates are "OET Call" Certificates or "OET Put" Certificates. The Certificates feature a Capitalised Exercise Price and a Security Threshold (which is equal to the Capitalised Exercise Price in respect of Call Certificates and Put Certificates). Both the Capitalised Exercise Price and the Security Threshold are adjusted by the Calculation Agent on a daily basis according to the cost of financing (the "Financing Rate").
