### BNP Paribas intragroup merger – Impact on legal name of service providers only

On 1 October 2022, BNP Paribas Securities Services SCA merged with its parent company, BNP Paribas SA.

From 1 October 2022:

BNP Paribas Securities Services SCA has ceased to exist as a distinct legal entity and the products and services previously provided by BNP Paribas Securities Services SCA are now provided by BNP Paribas SA.

References to BNP Paribas Securities Services SCA in the issuance documentation, are references to BNP Paribas SA (in respect of roles and services performed).
